The licensing process is capped at 20 business days, provided all required documents are in order.





#### Steps to Obtain the Service

### Access your personal account, through which you can:





Search for your company and upload the proof of applicant's capacity to apply and the company's commercial registry; you may add multiple companies.



View your draft license application.



Submit your application(s) and upload the required documents.



Follow up on application(s) that is/are incomplete in terms of formal or technical requirements.



Pay the required fees electronically via the integrated payment gateway powered by E-finance.




Track the status of the requested license.





#### Steps to Obtain the Service

#### To submit a license application



Search for your company, upload the proof of applicant's capacity to apply and the company's commercial registry. You can add multiple companies. Fill in the application details, upload the required documents, and choose to either save or submit the application.





### Steps to Obtain the Service

You can track the status of your submitted application(s). They will appear in any the following statuses:



Being reviewed by the General Department of Licenses at GAFI



Being reviewed by the competent licensing authorities



License approved



Required to pay license fee



Further action needed to complete the license application (e.g., site inspection – submission of original documents)



Requested license issued
